- In accordance with the Wildlife (Game) Regulations 1990, a Game Licence is required for hunters who wish to hunt Deer, Duck or Quail in Victoria. A Game Licence issued by the Department of Natural Resources and Environment is valid in Victoria only.
- Applicants are reminded that there are strict requirements regarding Firearms Licences and firearms registration. Contact your local Police Station, District Firearms Officer or the Central Firearms Registry for details.
- Game Licences are generally issued for three years, but may be issued for one year in certain circumstances. Concession licences may be issued for up to three years.
- A concession rate of half the basic fee for up to three years is available for people holding an eligible pension concession card. To claim this concession you must include a photocopy of your concession card with your application. The concession rate is also available for Juniors (between 12 and 17 years of age).
- All hunters applying for a Game Licence for "Game Birds - including Duck" must have firstly passed the Waterfowl Identification Test. This includes junior hunters.
- You must have your identification witnessed by one of the accepted witnesses listed below or at any Regional office of the Department of Natural Resources and Environment.

a justice of the peace or bail justice
a clerk of courts or petty sessions
a barrister or solicitor of the Supreme Court
a clerk to a barrister or solicitor of the Supreme Court
a councillor of a municipality, a town clerk or shire secretary
a manager of a bank or a postmaster
a minister of religion authorised to celebrate marriages
a member or former member of either House of the Parliament of Victoria
a member or former member of either House of the Parliament of the Commonwealth

a member of the Victoria Police
a legally qualified medical practitioner
a dentist, pharmacist or veterinary surgeon
a teacher with over five years experience
a public servant with over five years experience
a chartered accountant

- Before signing the declaration at the bottom of the form, please ensure that all statements on the form are true and correct in every detail. **There are heavy penalties for providing false or misleading statements.**
